By signing completing this application, I player/parent agree to the following: - By selecting a level for my child, I understand that ECYF Board and Coaches may move your child to another level better suited for his skills, size, or spot availability. - I will follow the playing rules, as set forth by the East Bay Youth Football and Cheer Association (EBYFC). - I will follow all guidelines as set forth by my team. - I will be responsible for returning/repairing/replacing all team equipment that is issued to me. - I understand that I am a member of this team for the entire season, or until properly released. - I understand that this team will be my home team from this point on, and that I must obtain an approved transfer from the league prior to going to another team. - I understand that the league may handle problems and questions as directed, and that the outcome may not always go my way. - I will not use, nor allow any person associated with me to use foul language, obscene behavior, or un-sportsmanlike Gestures. - I agree to act in an appropriate manner and to abide by all decisions of the coaching staff, executive board, league board, referees, or staff always. - I agree to play any position that I am assigned to, and that I will represent my teams and coaching staffs' decisions to the best of my ability. By signing this application, I agree for my child and family to participate in a sport activity, or an event sponsored by the EBYFC and the local team ECYF, its' agents, Directors, employees, coaches, or staff. I represent that my child is in good physical and mental condition. I understand that football and cheerleading are dangerous sports and that I, my son, and/or daughter will participate at our own risk. I agree that the EBYFC and/or any of its franchise teams will not be held liable for any injury or damage arising from their participation in any EBYFC sponsored event or competition. This waiver applies to all persons or entities acting on my, or my child's, behalf. I have read this application in its entirety, and I fully understand and agree with its terms. This authorization shall remain in effect for a period of 10 years from the date signed. I understand that participation in tackle football/flag football/cheerleading can be dangerous. Your child could be temporarily or permanently injured, and I hereby give my consent for my child to participate and compete in the EBYFC. I also hereby waive my right to privacy, and give the EBYFC, and its' authorized representatives, the right to verify any and all information regarding our participation. I expressly give EBYFC permission to access my child's school record for the express reason of verifying his age. I understand that ECYF is an organization that is run by volunteers, and I will be required to complete (7) 2-hour shifts on home game dates. A \$450 Volunteer deposit will be collected on Equipment Day that is refunded after my volunteer shifts are completed.

## **SOCIAL MEDIA POLICY AGREEMENT**

All ECYF Members shall abide by the following guidelines when using social media:

1. Be positive and respectful and always take the high road. When disagreeing with others' opinions, remain appropriate and polite. If you find yourself in a situation online that is becoming antagonistic, ask the ECYF Board of Directors or your sport coordinator for advice on how to disengage from the dialogue in a polite and respectful manner that reflects well on ECYF .
2. Do not post content that would harm ECYF or damage ECYF's reputation. Remember that even while you are on your own personal time, you are a representative of ECYF, and people may interpret your online postings or social interactions as though they were official ECYF statements.
3. Use good judgment when posting comments on any official ECYF sites. Bear in mind that your comments can create liability for ECYF. If you are unsure whether a comment is appropriate to post, either do not post it or obtain prior approval from the Board of Directors.
4. Be smart about what you publish. Once something is posted, it exists online forever. Ask yourself, "would I want to see this published in the newspaper or posted on a billboard tomorrow or ten years from now?" If the answer is "no," do not post.
5. Encourage others to engage in positive interactions on social media. If you are concerned about any ECYF Member's use of social media, please bring your concerns to the attention of your sport coordinator or a member of the ECYF Board of Directors.
6. Personally identifiable information (information, such as a name and date of birth and/or a street address which, when taken together, can identify a particular individual) should not be disclosed in any manner on official ECYF social networking sites without the approval of the sport coordinator or ECYF Board of Directors.

### **Violations of the Social Media Policy**

The East County Lions Youth Football & Cheer Board of Directors shall have the authority to monitor and enforce this social media policy. The East County Lions Youth Football & Cheer Board of Directors, and any individual appointed by the Board of Directors, shall have the authority to remove any inappropriate or offensive comments from official East County Lions Youth Football & Cheer sites and to block any individual or organization from posting on any official East County Lions Youth Football & Cheer social media platform if they determine, in their sole discretion, that such removal or block is in the best interests of East County Lions Youth Football & Cheer.
